- Awards will be presented three deep in Cruiser, Non-spinnaker, and Spinnaker Classes.
- This regatta shall be the second race of the EFYC two race series (spinnaker class) for naming as the 2010 winner of the Alfred I. DuPont Trophy for sail competition on the St. Johns River, which was first awarded in 1936.

SAILING INSTRUCTIONS

Kings Day Regatta

Alfred I. duPont Trophy series race Epping Forest Yacht Club November 13, 2010

1. RULES

The Regatta will be governed by these Sailing Instructions (SI), the rules of the First Coast Sailing Association (FCSA), the prescriptions of US Sailing, and the Racing Rules of Sailing, 2009-2012 (RRS).

2. MANAGEMENT

The race will be under the management of the Epping Forest Yacht Club, which is the organizing authority.

3. REGISTRATION AND ENTRY FEE

3.1 Entry must be made on the standard FCSA Entry Form with entry fee paid before the competitors meeting.

3.2 The entry fee shall be \$30.00 per boat. (\$25.00 for EFYC members billed to their account)

4. ELIGIBILITY

Only boats having a valid FCSA PHRF Certification may compete. Entrants must have completed registration and paid fees to the regatta organizing authority before becoming official competitors.

5. PARTICIPATION

Sailing is an activity that has inherent risk of damage to property or injury to persons. Competitors in this regatta are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, Epping Forest Yacht Club, sponsors, or any other organization or official) will not be responsible for property damage or injury to any competitor, including death, sustained as a result of participation in this regatta.

6. SCHEDULE OF EVENTS

- 1030 Race committee arrives at Epping Forrest Yacht Club Marina; race day registration opens in the lower level room of the EFYC marina building.
- 1145 Registration closes, competitors meeting.
- 1255 Warning signal, first start.
- 1600-1800 (approx) Awards at Epping Forest Yacht Club Mariners Deck in the marina.

7. CLASSES

7.1 The fleet will be divided into 3 classes: spinnaker, non-spinnaker, and cruiser.

7.2 The spinnaker and non-spinnaker classes shall start first. The cruiser class shall start second.

7.3 Awards and/or trophies will be awarded three deep in all three classes.

7.4 The spinnaker class will compete for recognition on the Epping Forest Yacht Club, Alfred I. duPont Trophy. T his race is the second in a two-race series. The first race was the duPont Cup Regatta held at Epping Forest Yacht Club in the Spring. The winner shall be determined via the Low Point System per RRS Appendix A.

7.5 The regatta is also race number 5 in the First Coast Sailing Association Fall Series for all three classes.

8. NOTICE TO COMPETITORS

Notices to competitors will be posted on the Official Regatta Notice Window located on the door of the Epping Forest Yacht Club Marina building (lower level).

9. CHANGES IN SAILING INSTRUCTIONS

Any changes in the Sailing Instructions will be approved and posted before 1145 on the date it will take effect.

10. SIGNALS MADE ASHORE

- 10.1 Signals made ashore will be displayed on the official club flag staff, next to the Harbormasters office.
- 10.2 Code Flag "AP", Answering Pennant, with two sound signals (one sound signal when lowered) means "The race is postponed. Do not leave the Harbor area." The time of the warning signal will be posted on the Notice Window before the lowering of the "AP".

11. COURSES

Courses will be as announced at the competitors meeting.

12. MARKS

Marks will be yellow and / or orange inflatable tetrahedrons or balls, stationary government marks, or other marks as designated by the RC.

13. THE START AND FINISH

- 13.1 The start line will be between an orange flag on the race committee boat (displaying the RC flag) at the starboard end and a pin-end buoy at the port end.
- 13.2 Yachts shall check in with the race committee prior to the warning/class signal for the first start by sailing past the stern of the race committee boat on a starboard tack and hailing their sail number. Yachts failing to check in may be scored DNS.
- 13.3 Races will be started in accordance with RRS 26 with the warning/class signal given five minutes before the starting signal. The warning/class signals for the second start will be given after the starting signal of the first start.
- 13.4 The warning/class signal (5 minutes before start signal) for the spinnaker and nonspinnaker classes will be a red flag ("B" signal) . The warning/class signal (5 minutes before start signal) for the cruiser class will be a yellow flag ("Q" signal).
- 13.5 The preparatory flag (4 minutes to 1 minute before the start signal) for all classes will be the "P" signal.

- 13.6 Rule 30.1, the "Round an End" rule shall be in effect regardless whether an "I" flag is or is not displayed on the RC boat. Yachts whose warning/class signal has not been made shall avoid interfering with yachts preparing to start. (This is modification of RRS Rule30.1)
- 13.7 Individual and general recalls will be made in accordance with RRS 29. In addition, as a convenience to competitors, the race committee will attempt to announce over VHF marine radio channel 68 the sail numbers of premature starters. If a general recall is signaled, the order of the starts will not change and subsequent starts will be delayed accordingly.
- 13.8 The finish line will be between the orange flag on the race committee boat (displaying the RC flag) and the pin-end buoy. The race committee will set the finish line in approximately the same position as the start line unless weather or other conditions require it be relocated.
- 13.9 The start and finish line shall be closed to all vessels not starting or finishing.
- 13.10 Yachts failing to cross the finish line within 3 hours of their start shall be scored DNF (modification of RRS 35).

14. PENALTIES

A one- or two-turn penalty shall apply in accordance with RRS 44.1 and 44.2. Any yacht that exonerates itself in this manner for a foul shall notify the race committee of such action after finishing.

15. PROTESTS

A notice to protest must be given by hail immediately after finishing with acknowledgement from the race committee. Protests must be submitted in writing not more than 30 minutes following the race committee's arrival back at Epping Forrest Yacht Club Marina. The Protest Committee will hear protests in approximately the order of receipt.
