## NOTICE OF RACE

- THE PREDICTED LOG CONTEST IS A TIME HONORED TRADITION THAT TESTS THE PILOTING SKILLS OF OWNERS OF ENGINE POWERED VESSELS. THIS CONTEST WILL TAKE PLACE ON THE ST JOHNS RIVER AND THE COURSE WILL BE ANNOUNED ON THE DAY OF THE RACE. ALL YOU HAVE TO DO IS PREDICT THE TIME IT WILL TAKE YOU TO COMPLETE THE COURSE.
- THE CONTEST WILL START AT 8AM WITH BOATS LEAVING THE DOCK EVERY TEN (10) MINUTES. EACH VESSEL WILL BE MOTOR POWERED ONLY AND ALL NAVIGATIONAL EQUIPMENT WILL BE TURNED OFF OR DISCONNECTED. EACH VESSEL WILL BE BOARDED BY AN OBSERVER ASSIGNED BY NAVY JAX YACHT CLUB. THE OBSERVER WILL BE THE ONLY ONE ON THE VESSEL WITH A TIME PIECE OF ANY KIND. THE OBSERVER WILL ALSO HAVE A TIME SHEET TO RECORD THE TIMES AT DESIGNATED LOCATIONS ON THE COURSE.
- ALL VESSELS ARE RESPONSIBLE FOR HAVING ALL LIFE VEST AND SAFETY EQUIPMENT ON BOARD. ALL VESSELS WILL BE CHECKED BY THE OBSERVER BEFORE LEAVING THE DOCK AREA.
- UPON COMPLETING THE COURSE, EACH CAPTAIN WILL SIGN THE TIME SHEET AND TURN IT IN AT THE REGISTRATION TABLE WITHIN 15 MINUTES.
- EVERYONE IS ENCOURAGED TO ENJOY DINNER AND DRINKS AT THE CLUB AFTER THE CONTEST. AWARDS WILL BE PRESENTED AT THIS TIME.
