### NOTICE:

Epping Forest will host a Blessing Of The Fleet in the Marina on Sunday, April 28<sup>th</sup>, after the DuPont Cup and all visiting yachts are invited to participate.

- The DuPont Cup Regatta has been contested annually at Epping Forest Yacht Club for the past 23 years.
- The DuPont Cup Regatta is the first in a two race series for Spinnaker Class to award the original 1936 Alfred I. DuPont Trophy for 2013. The second race is the Kings Day Regatta at Epping Forest Yacht Club to be contested in the fall of 2013.
- The regatta shall be contested in Cruiser, Non-spinnaker and Spinnaker Classes per the Performance Handicap Racing Fleet (PHRF) rules of the First Coast Sailing Association and participating yachts must hold a current Rating Certificate. ([www.sailjax.com](http://www.sailjax.com))
- Yachts will earn points for the First Coast Sailing Association Awards, as this is the fourth in the Spring FCSA series.
- Awards will be presented three deep in Cruiser, Non-spinnaker and Spinnaker Classes.

## SAILING INSTRUCTIONS

2013 DUPONT CUP

April 27th, 2013

### 1. RULES

The Regatta will be governed by (1) these Sailing Instructions, (2) the rules of the First Coast Sailing Association (FCSA), (3) the Racing Rules of Sailing, 2009-2012 (RRS)

#### 1.1 MANAGEMENT

The race will be under the management of the Epping Forest Yacht Club, which is the organizing authority.

#### 1.2 REGISTRATION AND ENTRY FEE

Entry must be made on the standard FCSA Entry Form with entry fee paid before the competitors meeting at 1100 hrs.

The entry fee shall be \$30.00 per boat or \$25.00 per boat for EFYC members or skippers with current U.S. Sailing Membership.

#### 1.3 ELIGIBILITY

Only boats having a valid FCSA PHRF Certificate may compete. Entrants must have completed registration with, and paid fees to, Epping Forest Yacht Club before becoming official competitors.

### 2. NOTICE TO COMPETITORS

Notices to competitors will be posted on the Official Regatta Notice Window located on the west wall window of the Epping Forest Yacht Club Marina building (Harbormaster's office).

### 3. CHANGES IN SAILING INSTRUCTIONS

Any changes in the sailing instructions will be posted before 1100 hours on race day.

#### 4. SIGNALS MADE ASHORE

4.1 Signals made ashore will be displayed on the EFYC marina flag staff, next to the Harbormasters office.

4.2 Code Flag "AP". Answering Pennant, with two sound signals (one sound signal when lowered) means "The race is postponed. Do not leave the Harbor area." The time of the warning signal will be posted on the Notice Window before the lowering of the "AP".

#### 5. SCHEDULE OF EVENTS

1000 hours: Race committee arrives at Epping Forrest Yacht Club, race day registration opens.

1100 Hours: Registration closes, competitors meeting.

1155 hours (approximate): Warning signal, first start.

1500-1700 hours: Trophies and awards at Epping Forest Yacht Club Mariners Deck in the marina.

#### 6. CLASSES and CLASS FLAGS

6.1 The fleet will be divided into 3 classes, spinnaker, non-spinnaker and cruiser (no spinnaker option in the cruiser class).

6.2 The spinnaker class shall start first; the non-spinnaker class and cruiser class shall start second.

6.3 The warning/class signal for the spinnaker class will be the "T" flag, red, white and blue. The warning/class flag for the non-spinnaker class and cruiser class will be the "B" flag, red.

6.4 The preparatory flag for all classes will be the "P" flag, blue with white square.

6.5 The spinnaker class will compete for recognition on the Epping Forest YC duPont Cup. This race is also the first race in a two race series by the spinnaker class for recognition on the Alfred I. duPont Trophy. The second race in the series shall be the Kings Day Regatta held in the fall at Epping Forest Yacht Club.

6.6 Awards and/or trophies for this race shall be awarded three deep in all three classes.

6.6 This is also race number 4 of 6 in the First Coast Sailing Association Spring Series for all three classes.

## 7. RACE AREA

The race area shall be between the Fuller Warren bridge to the north and the Buckman bridge to the south as depicted on the NOA Chart #11492

## 8. COURSES

Courses will be as posted at the competitors meeting.

## 9. MARKS

Marks will be permanent government navigation markers or orange/yellow inflatable markers as indicated for the courses.

## 10. START and FINISH

- 10.1 The start line will be between an orange flag on the race committee boat at the starboard end and a pin-end buoy at the port end.
- 10.2 Races will be started in accordance with RRS 26 with the warning/class signal given five minutes before the starting signal. The warning/class signals for the second start will be given after the starting signal of the spinnaker class..
- 10.3 Boats whose warning/class signal has not been made shall avoid interfering with yachts preparing to start.
- 10.4 RRS 30 Starting Penalties shall NOT be in effect for all starts. ("I", "Z" and "Black" flags) Starting line is "open" during starts.
- 10.5 Individual and general recalls will be made in accordance with RRS 29. If a general recall is signaled, the order of the starts will not change and subsequent starts will be delayed accordingly. In addition, as a courtesy only, the race committee will attempt to announce over VHF marine radio channel 68 any recall.
- 10.6 Boats failing to cross the start line within 10 minutes of their start signal will be scored DNS.
- 10.7 The finish line will be between the orange flag on the race committee boat at the starboard end and a pin-end buoy at the port end .The race committee will set the finish line in approximately the same position as the start line unless weather or other conditions require it be relocated.
- 10.8 The finish line shall be closed to all boats after starting except those finishing. Boats violating the closed finish line shall take a One-Turn (360 degree) penalty as prescribed in 13 below. (modification of RRS 28.2)
- 10.9 Yachts failing to cross the finish line within 3 hours of the start of their class shall be scored DNF (modification of RRS 35)

## 11. PENALTIES

While racing, the Two-Turns (720 degree) penalty or One-Turn (360 degree) penalty (RRS 31) will apply in accordance with RRS 44.1 and 44.2.

Any yacht that exonerates itself in this manner for a minor foul shall notify the race committee of such action after finishing.

## 12. PROTESTS

A notice to protest must be given to the race committee by hail immediately after finishing with acknowledgement from the race committee. Protests must be submitted in writing on a U.S. Sailing Protest Form (available from the Race Committee) not more than 30 minutes following the race committee's arrival back at Epping Forrest Yacht Club Marina. The Protest Committee will hear protests in approximately the order of receipt.

## 13. RADIO COMMUNICATION

As a matter of courtesy the race committee will attempt to announce over VHF radio on channel 68 any recall, change to course or other communication necessary for the proper and safe conduct of this regatta. This in no way removes the responsibility of the crews to adhere to the sailing instructions as posted. Official instructions will only be in accordance with these Sailing Instructions and RRS.

## 14. INSURANCE

As a condition of participation, members of the crew, guests and owners of the vessels participating assume all risks of accident and agree that Epping Forest Yacht Club and First Coast Sailing Association shall not be liable, under any circumstance, for loss or injury to participants or others, or the loss or damage to any yacht and shall hold Epping Forest Yacht Club and the First Coast Sailing Association free and harmless from and against any and all losses, costs, damages, attorney fees and liability of any kind or nature whatsoever growing out of or resulting from participation in the race.

30 As a condition of participation each boat shall be insured with valid third party liability insurance and be able to provide a copy if requested by the race organizers.
