Notice of Race

1 RULES

- 1.1 The rules governing the 2020 Old Timers Memorial will be: The Racing Rules of Sailing 2017-2020 (RRS), the 2020 Old Timers Memorial Notice of Race (NOR) the 2020 Old Timers Memorial Sailing Instructions (SI), the 2019 World Sailing Regulations, the FCSA 2020 Rating Policies and Rules and any special instructions issued by the HRYC Race Committee.
- 1.2 Any changes to the Notice of Race and/or Sailing Instructions will be posted at Regatta Network on the official notice board.

2 ADVERTISING

- 2.1 Advertising shall be restricted in accordance with World Sailing Regulations.

3 ELIGIBILITY AND ENTRY

- 3.1 The Old Timers Memorial is open to all single or multi-hulled sailing vessels, with a minimum of 20 feet LOA, having inboard or outboard auxiliary power, manned by an eligible captain and crew, and meeting all safety requirements of Section 15 (SI). The Race Committee may consider the qualification of a yacht by virtue of its history and/or survey.
- 3.2 Entering yachts shall choose either Performance or Cruising Class, with boats registering for the Cruising Class meeting the expectations described in the FCSA PHRF Ratings Rules (located at the following URL: <http://www.sailjax.com/FCSA-PHRF-Rules.pdf>). The Race Committee reserves the right to reclassify a yacht in the spirit of competition. Boats may declare either spinnaker or non-spinnaker in either Class, using their assigned FCSA PHRF rating.
- 3.3 Eligible yachts may enter by completing the entrance form on the Regatta Network page, located at: <https://www.regattanetwork.com/event/20765> The required fee may be paid online or sent to:

4 FEES

- 4.1 Required fees are as follows:
Entry fee shall be \$25.00. The entry fee shall be applied to the 2020 HRYC Commodores Cup Series if the boat registers for the full series. After May 22, there will be a \$10 late registration fee.

5 SCHEDULE

- 5.1 A single race is scheduled for Sunday May 24, 2020.
- 5.2 The scheduled time of the warning signal for the race will be 1055.
- 5.3 There are no shore side activities planned for this event.

6 MEASUREMENTS

- 6.1 Each entrant shall have a 2020 FCSA Valid Rating and will declare their rating at the time of registration.

7 SAILING INSTRUCTIONS

- 7.1 The sailing instructions will be available on the Regatta Network page.

8 THE COURSE

- 8.1 The Sailing Instructions for this race will provide details on course options. Racing will be held in the vicinity of Ponce Inlet, possibly promoting sailing near the shoreline north of the inlet. All course options will be

published in the Sailing Instructions. There is no planned skippers meeting for this event, though a remote virtual meeting might be scheduled.

9 SCORING

9.1 All yachts shall be scored using their FCSA Valid Rating and corrected *time on time*.

9.2 The Race Committee reserves the right to reclassify any yacht at its discretion

10 PENALTY SYSTEM

10.1 The Scoring Penalty, (RRS) 44.3 will apply. The penalty shall be one (1) percent of a yacht's elapsed time added to her corrected time. This changes Rule 44.3 (c) (RRS). A yacht taking a scoring penalty shall report it to the Race Committee within the protest time limit.

11 SAFETY REGULATIONS

11.1 All yachts should comply with all World Sailing Category 4 requirements.

12 SUPPORT YACHTS

12.1 All support yachts shall stay outside areas where yachts are racing from the time of the preparatory signal for the first class to start until all yachts have started the race; the Race Committee signals a postponement, general recall or abandonment.

13 RADIO COMMUNICATION

13.1 A boat shall neither send nor receive any radio, mobile phone or WIFI network transmissions or use any other device, technology or other aid which is not available to all boats. **Committee Boat and all racers shall monitor VHF Channel 72.**

14 AWARDS

14.1 Trophies will be given as follows:

1. 1st, 2nd and 3rd in all classes with 5 or more boats competing
2. 1st and 2nd in all classes with less than 5 boats competing

14.2 The awards banquet will be held at Halifax River Yacht Club on a date to be determined later this year. Dress is responsible casual. Reservations are necessary. Details will be provided to registered sailors when available.

15 INSURANCE

15.1 Each participating yacht shall be insured with valid third-party liability insurance with a minimum cover of \$250,000.00.

16 DISCLAIMER OF LIABILITY

16.1 The Race Committee will be in charge of all scheduled races. The Race Committee Chairman or his designate will have final decision over management issues of the race, including, but not limited to whether a yacht will be allowed to compete, penalties (except protest – which will be over-seen by the protest committee), scoring, eligibility of yachts to race and time limits.

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

Despite the schedule to race and despite the Race Committee's decision to race, it is **ALWAYS** the skipper's decision whether he, his vessel and/or his crew should participate in any race. The responsibility of the decision to race and any and all consequences lie **SOLELY** with the skipper, captain or owner/operator of the vessel. **YOU ARE RESPONSIBLE FOR THE SAFETY, HEALTH AND WELFARE OF YOUR VESSEL AND ANYONE ABOARD! YOU ARE FURTHER RESPONSIBLE FOR ACTIONS TAKEN BY YOUR CREW AND DAMAGE TO, OR CAUSED BY, YOUR VESSEL. THIS SHOULD ALWAYS GUIDE YOUR DECISION TO RACE AND YOUR ACTIONS WHILE RACING.** The Race Committee accepts **NO** responsibility for your decision to race and the consequences that accompany it.

Sailing Instructions

1 RULES

- 1.1** The rules governing the 2020 Old Timers Memorial will be: The Racing Rules of Sailing 2017-2020 (RRS), the 2020 Old Timers Memorial Notice of Race (NOR) the 2020 Old Timers Memorial Sailing Instructions (SI), the 2019 World Sailing Regulations, the FCSA 2020 Rating Policies and Rules and any special instructions issued by the HRYC Race Committee.
- 1.2** Any changes to the Notice of Race and/or Sailing Instructions will be posted at the Regatta Network on the official notice board at <https://www.regattanetwork.com/event/20765>.

2 NOTICES TO COMPETITORS

- 2.1** Any notices to competitors will be posted at HRYC on the official notice board and will also be available at <https://www.regattanetwork.com/event/20765>.
- 2.2** Communications via VHF radio shall be made on **channel 72**. All instructional communications via VHF radio will cease 5 minutes before the first warning signal.

3 CHANGES TO SAILING INSTRUCTIONS

- 3.1** Any change to the sailing instructions will be posted before 0900 on the day it will take effect, except that any change to the schedule of the race will be posted by 2000 hours on the day before it will take effect. Any changes will also be posted at <https://www.regattanetwork.com/event/20765>.

4 SIGNALS MADE ASHORE

No Signals made ashore will be displayed at any time.

5 SCHEDULE OF RACES AND ACTIVITIES

- 5.1** Date of racing is Sunday, May 24, 2020.
- 5.2** The scheduled time of the warning signal will be 1055 EDT.
- 5.3** There is one race scheduled, a single start, and a course that promotes sailing near the shore.

6 THE COURSE

- 6.1** Racing will start at the Red #2 bell buoy at the entrance to Ponce Inlet and will progress towards the northwest passing various points along the shore. The course will proceed from R#2 to a mark located east of Racing's North Turn Restaurant, continuing along the coast passing near the Sunglow Pier, and then near shore at Peck Plaza (large circular building) and continuing to the Main St Pier. Once the helmsman is able to sight along the north side of the pier, a vessel may turn either clockwise, or counterclockwise, and will continue to race back to R#2 for the finish.
- 6.2** Racers will be required to keep track of their times at each of these locations along the way on the Participants Log Sheet, provided as an Appendix to the Sailing Instructions.

7 MARKS

- 7.1** Marks are approximately 72"x 60" orange or yellow inflatable marks. If marks are not present along the racecourse then racers must pass on the shore side of the waypoints provided in section 7.2. Government marks may be used as part of the racecourse, if not these marks can be left to either side.

8 AREAS THAT ARE OBSTRUCTIONS

- 8.1** There are no areas that are designated as obstructions unless amended by the race committee signal boat.

9 THE START

- 9.1** The Cruising Class and the Performance Class warning will be at 1055 for the race. If no R/C is present to conduct the start, all signals will be made on VHF channel 72.

10 RECALLS

- 10.1** Display of code flag "X" and one sound signal shall signal individual recalls. A boat recalled shall be notified by hail and on VHF channel 72 if possible; however, it is the responsibility of any yacht that is OCS to properly clear themselves.
- 10.2** Display of code flag "I" as the preparatory flag requires a yacht that is OCS within one minute of the start to round an end of the starting line before starting.

11 THE FINISH

- 11.1** The finish line will be between the R#2 buoy and a line extending due south from the buoy. Finishers are to keep the buoy to starboard (the west) and within 200 feet. A boat finishes when the buoy is at a bearing of due north from the helmsman's position.

12 PENALTY SYSTEM

- 12.1** The Scoring Penalty, rule 44.3 (RRS), will apply for those boats not exonerating themselves under Rule 44.1. The penalty shall be one (1) percent of a yacht's elapsed time added to her corrected time. This changes Rule 44.3 (c) (RRS). A yacht taking a scoring penalty shall report it to the Race Committee within the protest time limit.

13 TIME LIMITS AND TIME REFERENCE

- 13.1** Time limits for various segments of the race are provided to systematically shorten the course to allow for a completed race. The time limit for all classes is 1800 (6 pm).

If no boat has made it to the Sunglow Pier by 1430, the boats will turn back to finish at R#2 from here.
If no boat has passed the first mark by 1500, the finish will end at the North Turn.

If no boat has made it to the Sunglow Pier by 1600, then the finish will be at the Sunglow Pier.

If no boat has made it to Peck Plaza by 1600, then the finish will be at Peck Plaza.

If no boat has made it to the Main St. Pier by 1600, then the finish will be at the Pier.

If a boat makes it to the Main St. Pier before 1600, but no boat finishes by 1800, then the times recorded at the Pier will be used to score the finish. If needed, the R/C will use the furthest mark reached by the majority of the fleet to score the race.

- 13.2** Boats failing to finish by 1800 will be considered DNF.

- 13.3** The time reference for all boats shall be that which is provided by the National Institute of Standards and Technology time as broadcast by radio station WWV in Fort Collins Colorado. These may be accessed by telephone at 303-499-7111, Internet at <https://time.gov/> or by radio. The station radiates at 10,000

Watts on 5, 10, and 15 MHz; and 2500 Watts on 2.5 and 20 MHz. Each competitor is responsible for calibrating their own clocks.

- 13.4** All boats are strongly encouraged to use the RaceQs smartphone application (<http://raceqs.com/>) to track their boat in the races. This free application will allow competitors to replay the race, with an opportunity to see where they may have performed well, or poorly, with respect to the other boats in the fleet. In addition, since the application uses GPS time to report position and location it can serve as a verification of events on the water, possibly to verify the reported finish time, or interactions between boats in the event of a protest.

14 PROTESTS AND REQUESTS FOR REDRESS

- 14.1** U.S. Sailing [Protest forms](#) are available at HRYC and online. Protests shall be filed on a U.S Sailing Protest Form and be delivered within the protest time limit.
- 14.2** The protest time limit is 1200 on the day after the race. Boats that intend to file a protest must inform the R/C on the water of their intentions. All boats involved in the protest should be contacted by VHF and informed of their involvement by the boat filing the protest.
- 14.3** The same time limit applies to protests by the Race Committee and Protest Committee about incidents they observe in the racing area and to requests for redress. This changes rules 61.3 (RRS) and 62.2 (RRS).
- 14.4** Protests shall be filed in person at HRYC using the standard US Sailing Protest form.
- 14.5** Notices of protests by the Race Committee or Protest Committee will be posted in accordance to rule 2.1 of the Sailing Instructions to inform competitors under rule 61.1(b).
- 14.6** Protest hearings shall be scheduled as soon as possible after boats return to shore. All parties listed on the protest form will be advised of the time of the protest hearing. All protests hearings will be held at HRYC, 331 Beach St., Daytona Beach FL.
- 14.7** A list of boats that, under instruction 14.4, have acknowledged breaking rule 42 or have been disqualified by the Protest Committee will be posted before the protest time limit.
- 14.8** Breaches of instructions 16 and 24 will not be grounds for a protest by a boat. This changes rule 60.1(a). Penalties for these breaches may be less than disqualification if the protest committee so decides.
- 14.9** Decisions of the Protest Committee will be final as provided in rule 64.
- 14.10** All boats shall always carry a US Sailing protest form and a standard protest flag.

15 SCORING

- 15.1** 1. Scoring will be the low point system. There is only one race for this event.
- 15.2** All boats shall be scored using their FCSA PHRF rating and corrected *time on time*.
- 15.3** The Race Committee reserves the right to reclassify any boat at its discretion

16 SAFETY REGULATIONS

- 16.1** Check-in: Boats shall sail within hailing distance of the committee boat and state their boat name and sail number and fleet. Check-in by VHF on channel 72 is also allowed.
- 16.2** A boat that retires from a race shall notify the race committee as soon as possible.
- 16.3** All boats shall carry all the necessary safety equipment required by law, regulation, or class rules.
- 16.4** All boats competing in the Old Timers Memorial shall comply with all ISAF Category 4 requirements

17 REPLACEMENT OF CREW OR EQUIPMENT

- 17.1** Substitution of competitors will not be allowed without prior written approval of the Race Committee.

18 EQUIPMENT AND MEASUREMENT CHECKS

- 18.1** A boat or equipment may be inspected at any time for compliance with the class rules, the FCSA Rating Policies and Rules, the Sailing Instructions and all other rules and policies that apply. On the water, a boat may be instructed by a Race Committee to proceed immediately to a designated area for inspection.

19 OFFICIAL BOATS

19.1 Official boats will be marked with a race committee flag, or will be identified on channel 72..

20 SUPPORT BOATS

20.1 All support boats shall stay outside areas where boats are racing from the time of the preparatory signal for the first class to start until all boats have started the race, the Race Committee signals a postponement, general recall or abandonment.

21 RADIO COMMUNICATION

21.1 A boat shall neither send nor receive any radio, mobile phone or Wi-Fi network transmissions while racing that are not available to all boats.

22 PRIZES

22.1 Prizes will be given as follows:

- 1st, 2nd and 3rd in all classes with 5 or more boats competing
- 1st and 2nd in all classes with less than 5 boats competing

22.2 Prizes will be awarded at the HRYC Sailing Awards Dinner at a date to be determined.

23 DISCLAIMER OF LIABILITY

23.1 The Race Committee will be in charge of all scheduled races. The Race Chairman or his designate will have final decision over management issues of the race, including, but not limited to whether a boat will be allowed to compete, penalties (except protest – which will be over-seen by the protest committee), scoring, eligibility of yachts to race and time limits.

Despite the schedule to race and despite the Race Committee's decision to race, it is **ALWAYS** the skipper's decision whether he, his vessel and/or his crew should participate in any race. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

24 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$250,000.00 (USD).
