

## AISC Notice of Race – July 13, 2024

Committee Boat - Nan Walker on her pontoon boat "Tiki Time"

Race Committee Chairperson – Nan Walker, cell (410) 991-5805

All boats should monitor VHF channel 71 for START instructions and ongoing communication during the race.

1. **OA, Rules** - The Amelia Island Sailing Club is the Organizing Authority for the race, which will be governed by *The Racing Rules of Sailing 2021-2024, Updated 2022* (Rules, RRS).
2. **Schedule of Race** (All times GPS)
  - a. 1045 – Roll Call
  - b. 1054 – Six-minute warning
  - c. 1055 – Five-minute warning (engines off)
  - d. 1056 – Four Minute warning
  - e. 1059 – One-minute warning
  - f. 1100 – RACE START for the 1<sup>st</sup> of 3 races. Subsequent races to start as noted below in section 3 "Race Course."
3. **RACE-COURSE** – Approximately 2.2 nautical miles. Wind Forecast out of the South/Southeast 3-6 mph, gusting to 10. Three short races will be held. Races 2 & 3 will start approximately 6 minutes after the last boat finishes the previous race and as announced by the committee boat. Scores from the three races will be added to determine the overall winner.
4. **START LINE** – Imaginary line between Amelia River Lighted Buoy Green 1 and Red 2

Mark 1 – Amelia River Lighted Buoy Red 4 (port rounding)

Mark 2 – Cumberland Sound Lighted Buoy Green 23 (port rounding)

Mark 3 – Cumberland Sound Lighted Buoy Green 25 (port rounding)

FINISH LINE – Imaginary line between Amelia River Lighted Buoy Green 1 and Red 2. Leave Green to port.

***Stay alert on channel 71 for potential course modifications should the winds shift materially from the forecast.***

**Record your GPS time when the bow of your boat crosses the finish line. A headsail set forward of the bow does not qualify as a finish. This is a change to align with the *Racing Rules of Sailing 2021-2024*. Whisker poles may be used, must be attached to the mast and their length cannot exceed the boat's LP measurement.**

**Report your time to Wilby Whitt on Misty via VHF Channel 71, or text to 904-210-2087.**

5. **COURTESY BROADCAST:** The Race Committee will use VHF Channel 71 to attempt to broadcast information on boats early over the line. Failure to receive or hear such radio transmission will not be grounds for redress. This is a change to RRS 60.1.
6. **RETIREMENT:** Any competitor retiring from the race shall immediately notify the Race Committee on Channel 71.
7. **DISCLAIMER OF LIABILITY:** Competitors participate in the regatta entirely at their own risk. See RRS 4, "Decision to Race". The organizing authority will not accept any liability, nor be liable, for any damage, personal injury or death sustained in conjunction with, prior to, during or after the regatta.
