

2025 COASTAL CUP NOTICE OF RACE

The Coastal Cup is an annual offshore sailing race from Amelia Island, FL to St. Simons Island, GA. The race is hosted by the Golden Isles Sailing Club. Proceeds go to the Golden Isles Community Sailing Center to help fund its youth sailing programs.

1 RULES

1.1 The 2025 Coastal Cup race shall be governed by *The Racing Rules of Sailing 2025-2028*, except as modified by this Notice of Race and the Sailing Instructions. The Golden Isles Community Sailing Center is the Organizing Authority for this race.

1.2 Rule 42 is changed so that engines may be used for propulsion with the incurrance of a motoring penalty as described in the Sailing Instructions.

1.3 Rule 52 is changed so that races may be sailed with the assistance of self-steering gear, electric or wind.

2 ELIGIBILITY AND ENTRY

2.1 The race is open to monohull yachts that are self-righting, properly rigged and fully seaworthy.

2.2 Eligible boats may enter by completing the attached form and sending it with the required fee to the address below, or by registering online at gisc.club.

4 CLASSES AND HANDICAPS Classes will be established for PHRF Spinnaker and PHRF Non-spinnaker. PHRF ratings will be assigned to each vessel.
